1. WELCOME

Mayor Dalziel welcomed members and guests to the Mayoral Forum. She welcomed new Chief Executives Suzette van Aswegen and Fergus Power to their first meeting of the Forum. Also welcomed was Warren Gilbertson the new CREDs Project Manager, who will be officially starting on 8 January 2018.

Apologies were accepted from Mayor Gary Kircher and Chief Executives Stuart Duncan and Dr Karleen Edwards. It was noted that Mayor Kircher was representing the Forum at a tourism event arranged by the Queenstown Lakes District Council.

2. CONFIRMATION OF AGENDA

The following matter, not on the agenda, was raised for discussion at item 13 General Business – election of Lisa Tumahai as Kaiwhakahaere of Te Rūnanga o Ngāi Tahu.

3. MINUTES OF CANTERBURY MAYORAL FORUM MEETING: 25 August 2017

The minutes of the meeting held on 25 August 2017 were confirmed and the action points were noted.

The Forum was advised that all items on the action list, except those relating to the release of Canterbury Economic Development Strategy (CREDS) funding by the Ministry of Business Innovation and Employment (MBIE), were complete.

Bede Carran and the Timaru District Council were thanked for the work done on winding up the Canterbury Economic Development Company Ltd.

4. CHRISTCHURCHNZ

Dr Therese Arseneau and Joanna Norris were welcomed to the meeting.

Ms Norris introduced the presentation by providing some background on ChristchurchNZ. The agency was established in July 2017 from the merger of Christchurch and Canterbury Tourism and the Convention Bureau, and the Canterbury Development Corporation. The formation of ChristchurchNZ is an opportunity to ignite a bold ambition for Christchurch and Canterbury.

Dr Arseneau explained that the rationale for ChristchurchNZ was integration across sectors and to link with analysis from other sectors.

Noting that ChristchurchNZ is working with the Christchurch City Council on a major events strategy, it was explained that there are other events throughout Canterbury, like A&P shows, that are a great way for visitors to experience New Zealand.

David Bromell was asked to work with ChristchurchNZ to identify opportunities to co-ordinate major events planning across the region and with neighbouring regions.

Mayor Dalziel thanked Joanna and Therese for their presentation and invited Joanna to participate in Mayoral Forum meetings as a non-voting member.

5. Engaging with the new Government

David Bromell was thanked for some initial analysis circulated to Mayors as background to preparation of the Forum's briefing letters to incoming Ministers.

It was agreed that while the letters to Ministers would highlight key issues, there will be some issues that councils will raise with the new Government individually.

The forum supported:

- the proposal to request meetings with clusters of ministers, for example immigration, agriculture, rural communities and education
- inviting the Minister for Local Government to the first Mayoral Forum meeting of 2018
- the value of including field trips when meeting Ministers
- replacing 'irrigation infrastructure' with the more accurate description, 'water infrastructure', in future CREDS strategy documents and communications
- emphasising that water storage is protection against climate change

- continuing to work with lines companies and other stakeholders to increase the amount of accessible telecommunications fibre across the region
- a co-ordinated approach when applying for regional development funding, including links to the South Island story.

The meeting adjourned between 10.50 and 11.09 am

6. Canterbury Water Management Strategy update

Cr Claire McKay and Caroline Hart were welcomed to the forum.

Cr McKay presented the report attached to the agenda and advised that all zone committee members will be invited to attend the Canterbury Water Management Strategy (CWMS) symposium to be held in April 2018.

9. Proposed Canterbury Multi-Use Arena

Mayor Dalziel reported that the Minister for Greater Christchurch Regeneration had just announced that the existing contract for the proposed Sports Facility will be cancelled and urgent work was to be undertaken on a new build-only contract. She advised that any consideration of regional funding for a multi-use arena would not need to be included in 2018–2028 Long Term Plans.

10. Church Property Trustees request for support for Lotteries application for Christ Church Cathedral reinstatement

Mayor Rowley advised that he had received a request for support for a Lotteries application for Christ Church Cathedral reinstatement. Assuming that other councils has also received this request, he suggested the consideration of a collective reply. It was noted that this was not a request for funding but for support for a funding application.

It was noted that a Cathedral Reinstatement Trust may be responsible for fundraising, pending the introduction of legislation to the House.

There was backing for supporting this application, but it was also noted that a number of churches with significant heritage and community value across our region had been damaged by the earthquakes.

- 1. Write to the Church Property Trustees expressing support for any application for Lottery funding for the reinstatement of the Christ Church Cathedral; and**
- 2. would support applications for fund raising for other damaged historical churches in Canterbury.**

CREDS project update

Purpose

1. This paper:
 - reports on implementation of Canterbury Regional Economic Development Strategy (CREDS) projects funded by the Regional Growth Programme
 - seeks feedback on the format and content of the quarterly report.

Recommendations

That the Canterbury Mayoral Forum:

- 1. receive the March quarterly report on implementation of CREDS projects funded by the Regional Growth Programme**
- 2. note that this is the proposed format of a quarterly report to the Mayoral Forum and to the Ministry of Business, Innovation and Employment**
- 3. provide feedback on the format and content of the report.**

Background

2. When the Mayoral Forum launched the refreshed CREDS for 2017–19 in June 2017, Ministers announced funding of \$2.185m for 11 ‘accelerator projects’ funded by the Regional Growth Programme.
3. A CREDS Project Manager was appointed from January 2018 – funded as one of the 11 projects by the Ministry of Business, Innovation and Employment (MBIE) and Environment Canterbury.
4. We are working with Abby Cheeseman, our liaison official in MBIE, to rationalise reporting across the various funding agreements Environment Canterbury has signed with MBIE on behalf of the Mayoral Forum.

Quarterly report

5. A quarterly report will be prepared and presented at each quarterly meeting of the Mayoral Forum, then provided to MBIE and copied to the Senior Regional Official.

6. While this duplicates summary information in the Mayoral Forum's Three-year work programme, the CREDS quarterly report is primarily designed to meet reporting requirements in funding agreements with MBIE.
7. The Project Manager seeks feedback on the format and content of the report.

Cost, compliance and communication

Financial implications

8. The report will track implementation against agreed project budgets.

Risk assessment and legal compliance

9. Reporting on delivery against project milestones is a contractual requirement of our funding agreements with MBIE.
10. When Environment Canterbury on behalf of the Mayoral Forum contracts with suppliers, legal advice is obtained as appropriate from Environment Canterbury's General Counsel.

Communication

11. Following Mayoral Forum meetings, the CREDS project updates will be published with the agenda and papers from the meeting on the regional forums website (<http://www.canterburymayors.org.nz>).



The story of the CREDS

Advocating on economic and social development opportunities for Canterbury was a commitment in the Canterbury Local Authorities' Triennial Agreement for 2013–16. This commitment has been re-affirmed in the Triennial Agreement for 2017–19.

Key drivers are demographic trends, particularly the region's ageing population, and a sense of urgency about positioning the region's underlying economy for when earthquake recovery and rebuild cease to inflate economic activity and employment.



Seven priority work programmes

In February 2017, the Mayoral Forum and CREDS reference group re-affirmed the relevance and strategic importance of the seven CREDS work programmes initiated in 2015.

INFRASTRUCTURE, REGULATION AND INVESTMENT

- 1. Integrated regional transport planning and infrastructure investment**
- 2. Digital connectivity: extension and uptake of fast broadband in rural areas**
- 3. Freshwater management and irrigation infrastructure.**

HUMAN AND SOCIAL CAPITAL

- 4. Education and training for a skilled workforce**
- 5. Newcomer and migrant settlement: skilled workers, cohesive communities.**

WORKING WITH INDUSTRY

- 6. Value-added production**
- 7. Regional visitor strategy**

CREDS funding proposals

Purpose

1. This paper seeks Mayoral Forum agreement in principle to apply for project funding from the Senior Regional Official's (SRO's) 2017/18 budget for Canterbury.

Recommendations

That the Canterbury Mayoral Forum:

1. **agree in principle to submit funding proposals to the Senior Regional Official for:**
 - 1.1. **identification and web publication of a calendar of South Island major events, to support alignment, promotion and co-ordination (to a maximum of \$150,000)**
 - 1.2. **seed funding and securing of an anchor tenant site in the Agri-Science and Innovation Pavilion at the National Agricultural Show in November 2018 (to a maximum of \$50,000).**

Background

2. SROs each have a budget of \$200,000 per region. Canterbury has not drawn on its SRO budget in the year to 30 June 2018. Any unspent funding is re-allocated to another region.
3. The application process is relatively straightforward, and decisions on funding proposals are made by the Senior Regional Officials group.

Proposal 1: South Island major events calendar

4. In August 2017, the Mayoral Forum identified a need for co-ordination and alignment of major events – within Canterbury, with adjacent regions, and across the South Island.
5. A calendar of South Island events will be useful to:
 - inform and encourage co-ordination of major events
 - promote festivals and events, and help disperse visitors and keep them in the South Island longer

- support South Island Regional Transport Chairs, who are asking for information on visitor flows to support transport planning
 - inform planning by transport agencies and NZ Police, and agencies like St John that provide first aid services.
6. The existing Eventfinda website (<https://www.eventfinda.co.nz/>), although part-funded by central government, does not provide a calendar view, and making South Island tour's visible from the Home page will cost around \$25,000 per year.
 7. The secretariat is exploring two other options for building a dedicated web page off an existing site:
 - Christchurch Airport's South website (<https://south.co.nz/>) – *preferred option*
 - ChristchurchNZ's website (<http://www.christchurchnz.com/new-zealand/>).
 8. The funding sought is to a maximum of \$150,000 to:
 - consult with relevant destination marketing and regional tourism organisations to inform the project plan and obtain their buy-in and support
 - design processes for the on-going operation of the digital events calendar
 - assess and confirm the longer-term sustainability and operation of a digital events calendar.
 - design and build an appropriate portal
 - manage the digital events calendar
 - evaluate uptake and use.
 9. Mayors Winston Gray, Sam Broughton and Graham Smith would be the Mayoral Forum sponsors for this project.

Proposal 2: Agri-Science and Innovation Pavilion

10. Following an approach last year from Geoff Bone, Event Director, we have identified an opportunity for the Mayoral Forum to support and be an anchor tenant in an Agri-Science and Innovation Pavilion (500m²) at the 2018 National Agricultural Show (formerly the Canterbury A&P Show). The other anchor tenants are likely to be the Ministry for Primary Industries, KPMG and the Lincoln Hub.
11. This is an opportunity to promote the Mayoral Forum's leadership of the Canterbury Water Management Strategy, and the application of technology to improve productivity and living standards within an environmentally sustainable framework.
12. Environment Canterbury is assessing the value of committing staff time and resource to the Pavilion – to partner with Zone Committees and industry to 'show and tell' the CWMS story and the application of science, regulation and technology to address

environmental damage, improve water quality and secure a sustainable future. The costs of doing this well over the three days are considerable.

13. An indication of the willingness of Mayors and Chief Executives to help staff the Mayoral Forum exhibition space over the three days of the Show will help us assess whether and how to proceed with a funding proposal.
14. Mayor Craig Rowley would be the Mayoral Forum sponsor for this project.

Next steps

15. In light of direction and decisions made at this meeting, the secretariat will keep Forum members informed of progress and report to the next meeting on 25 May 2018.

Engaging with central government

Purpose

1. This paper provides some information on the Provincial Growth Fund and proposes an approach to engaging with Ministers and central government agencies on agreed Mayoral Forum priorities.

Recommendations

That the Canterbury Mayoral Forum:

1. **request the secretariat to:**
 - 1.1. **circulate additional information on the Provincial Growth Fund as it comes to hand**
 - 1.2. **explore opportunities to work with the Senior Regional Official and CREDS lead Mayors on opportunities to access small-scale investment funding, where the benefits demonstrably exceed the transaction costs of securing the resource**
 - 1.3. **facilitate regional co-ordination of infrastructure funding proposals submitted by Canterbury councils**
2. **accept the offer of Environment Canterbury to engage a consultant to support the Mayoral Forum's engagement with central government officials and Ministers on policy settings for immigration and international education**
3. **agree to invite Hon Kelvin Davis, Malcolm Johns, Joanna Norris, Graeme Abbot and Andy Roberts to the Mayoral Forum working dinner on Thursday 24 May for discussion of regional visitor strategy.**

Background

2. At its meeting on 1 December 2017, the Mayoral Forum:
 - received some initial analysis of implications of the new Government for Canterbury
 - identified two regional priorities for engaging with Ministers:
 - policies on immigration and international education that work both for Canterbury and for New Zealand as a whole

- water infrastructure and freshwater management
 - agreed to maintain a co-ordinated approach when applying for regional development funding.
3. The Canterbury Policy Forum continues to monitor the development and implementation of central government policies and their implications for Canterbury.

Tuawhenua / Provincial Growth Fund

4. The Provincial Growth Fund (PGF) was launched in Gisborne on 23 February 2018. The Fund (totalling \$1b per year of existing and new funding) was a commitment in the Coalition Agreement with NZ First. The Fund will invest in regional rail, support the planting of a billion trees over the next 10 years, investigate the future of the upper North Island ports, and provide for investment in local, regional and large-scale capital projects.
5. This paper has been prepared prior to the launch. The following information is based on information in the Budget Policy Statement (14 December 2017) and conversations with Wellington officials.
6. We expect that the PGF will be open to regions (not cities), including Canterbury – but Canterbury is unlikely to be a priority region. Regional co-ordination of funding proposals is likely to be strongly encouraged.
7. The PGF will comprise three tiers of investment:
- small-scale investments (building on the Regional Growth Initiatives fund)
 - medium- to large-scale sector-based investments (such as the 1 billion Trees Programme)
 - large infrastructure investments.
8. Investment criteria are likely to be:
- **jobs and sustainable economic development:** investments that support increased jobs and sustainable economic development over the long term, particularly in regions and sub-regions where unemployment is high and there are significant social challenges
 - **social inclusion and participation:** investments that support increased social inclusion through effective training, work preparation and support that enables more people to fully participate in work and society
 - **climate change and environmental sustainability:** investments that support opportunities to achieve New Zealand's climate change commitments and encourage more sustainable and productive use of land, water and other resources
 - **resilience:** investments that increase regional and national resilience by improving critical infrastructure and focusing on opportunities to grow and diversify our exports and economy.

9. Information released at the time of the launch on 23 February will be shared at the Mayoral Forum meeting on 2 March 2018.
10. In addition to the PGF, Senior Regional Officials have access to a budget of \$200,000 per region per annum. Two proposals for funding from this budget in F2017/18 are to be discussed in **agenda item 7**. We expect to be able to apply for funding to a similar level in F2018/19.
11. Recommended actions – request the secretariat to:
 - circulate additional information on the PGF as it comes to hand
 - explore opportunities to work with the Senior Regional Official and CREDS lead Mayors on opportunities to access small-scale investment funding, where the benefits demonstrably exceed the transaction costs of securing the resource
 - facilitate regional co-ordination of infrastructure funding proposals from member councils within the Canterbury region.

Policy advocacy

Immigration and international education

12. On 28 November 2017, the Mayoral Forum sent a briefing letter on immigration, newcomer settlement and international education to the incoming Ministers of Immigration, Agriculture, and Employment, and the Ministers for Ethnic Communities, Rural Communities, and Regional Economic Development.
13. Hon Iain Lees-Galloway, Minister of Immigration, responded to this letter on 14 December 2017. Key points were:
 - the Government is focusing on improving the migration system and reducing exploitation, rather than setting a specific target to reduce immigration
 - the Government will create regionally focussed skills shortages lists
 - 'getting the balance right' in international education – ensuring a potential pool of highly skilled migrants for New Zealand's labour market while ensuring we do not provide a backdoor to residence
 - the Minister welcomes the Mayoral Forum's input to his work with colleagues and immigration officials to achieve the Government's immigration commitments.
14. The secretariat has begun drafting a policy discussion framework and will develop this in consultation with staff at the Ashburton District Council, the Canterbury Employers' Chamber of Commerce and ChristchurchNZ.
15. To support high-level discussion with central government officials and Ministers, the discussion framework takes the form of a table with:
 - current policy settings for immigration and international education

- proposed Government policies (from party manifestoes and public statements since the formation of a Government)
 - policy options that could work for Canterbury and the South Island – and for Auckland and New Zealand as a whole
 - key evidence that supports this analysis.
16. On 27 February, David Bromell and Simon Fraser attended a Regional Immigration Policy Session hosted by the Canterbury Employers' Chamber of Commerce, with staff from the University of Canterbury, Lincoln University, Ara Institute, BusinessNZ, ChristchurchNZ and the Christchurch City Council.
17. Following further consultation with lead Mayors and additional external stakeholders (such as Dairy New Zealand, Federated Farmers and some key tourist operators), we will circulate the table to all Mayors and Chief Executives for comment.
18. We propose to engage a consultant with significant experience in the Department of Prime Minister and Cabinet to support the Forum's engagement with officials in central government agencies and with Ministers on the policy options we identify. Environment Canterbury has agreed to fund this piece of work. Helen Wyn and Abbie Cheeseman will facilitate this engagement.
19. By mid-year, the objective is for a deputation of Mayors (Lianne Dalziel, David Ayers, Donna Ayers and Sam Broughton) to meet with a cluster of Ministers to present *constructive immigration and international education policy options* that have potential to serve the interests of Canterbury and the South Island while achieving the Government's objectives and addressing its concerns.

Water infrastructure and freshwater management

20. Steve Lowndes and Claire McKay will report on the January 2018 visit of Hon David Parker in the CWMS update (**agenda item 10**).

Mayoral Forum working dinners

21. The Forum may wish to reflect briefly on the working dinner held with Hon Clare Curran and invited guests on Thursday 1 March, including:
- what worked – and what we might do differently next time
 - any follow-up actions required, and next steps.
22. A draft programme of Mayoral Forum working dinners circulated in December 2017 proposed that the May dinner focus on regional visitor strategy, facilitated by Mayor Winston Gray with Mayors Sam Broughton and Graham Smith.

23. If the Forum agrees, we propose to invite the following guests to the working dinner on 24 May 2018:

Memorandum of Understanding with Nagano Prefecture, Japan

Purpose

1. This paper invites decision on whether or not the Canterbury Mayoral Forum wishes to enter into a high-level, region-to-region Memorandum of Understanding (MOU) with the Nagano Prefectural Government.

Recommendations

That the Canterbury Mayoral Forum:

1. **decide whether or not to enter into a region-to-region Memorandum of Understanding with the Nagano Prefectural Government.**

Background

2. On 25 August 2017, the Mayoral Forum received a report on a proposed region-to-region MOU with Nagano Prefecture and:
 - **agreed in principle** to develop a region-to-region relationship with Nagano Prefecture, Japan
 - **directed** the secretariat to work with Christchurch Educated and Christchurch City Council staff to draft an MOU with Nagano Prefecture and report back to the Mayoral Forum on 1 December 2017.
3. The report to the August meeting (attached as Appendix A) included a draft MOU.
4. Discussion at the December 2017 meeting was deferred to the March 2018 meeting, as the Chair will now not travel to Japan until October 2018.
5. Tony Oikawa, Japan Market representative for Christchurch Educated, visited Nagano in November 2017 and provided the report attached as Appendix B.

Reasons to proceed with an MOU

Existing partnerships in education

6. A region-to-region MOU would build on existing projects and exchanges in education and training. Canterbury education providers have historically been very strong in Japan, stronger than any other region in that market outside of Auckland.

7. A delegation from the University of Nagano is visiting Christchurch in June 2018 to finalise a student exchange programme in Global Management and Food and Health Science.
8. Mayor Kiyooki Motai (Ikeda-machi district) hopes to head a delegation to Canterbury during 2018, with a particular focus on Lincoln University, agriculture and agri-tourism.
9. Governor Shuichi Abe hopes to accompany a delegation to Canterbury in June 2019, in relation to existing programmes with Ara Institute and Lincoln University.

Additional opportunities

10. On 23 January 2018, negotiations for the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) were concluded in Tokyo. The CPTPP is a free trade agreement involving 11 countries in the Pacific region, including **New Zealand**, Australia, Brunei Darussalam, Canada, Chile, **Japan**, Malaysia, Mexico, Peru, Singapore, and Viet Nam.
11. Japan is hosting the 2019 Rugby World Cup (20 September – 2 November) and the Summer Olympics in 2020.
12. A region-to-region relationship beyond existing tertiary education programme partnerships could encourage and facilitate business-to-business contacts in the agriculture, food and beverage, tourism, manufacturing and technology sectors. Public service exchanges and training programmes are also an option, building on a previous exchange hosted by the Christchurch City Council.

Reasons not to proceed with an MOU

13. Christchurch Educated and its parent body ChristchurchNZ have existing relationships and commitments in the education space. There is currently no mechanism or funding however, to broker business introductions with the aim of forming business partnerships. ChristchurchNZ and the Canterbury Employers' Chamber of Commerce typically refer this kind of activity to New Zealand Trade and Enterprise (NZTE).
14. The Nagano Prefectural Government has indicated some willingness to part-fund Tony Oikawa to develop the project, but while Tony has very strong relationships in education, he does not have an existing network of relationships in the private sector. Neither does the Mayoral Forum have a budget to part-fund facilitation or brokering of business introductions. (There may, however, be opportunities to progress this through NZTE.)
15. The Mayoral Forum and Canterbury councils have not to date evidenced strong enthusiasm for the MOU proposal.

Cost, compliance and communication

Financial implications

16. There are no direct financial implications for the Mayoral Forum or member councils. The proposed MOU is high level and well aligned with the Mayoral Forum's exercise of leadership, facilitation and advocacy for the Canterbury region.
17. Objectives agreed in the MOU would, however, require some investment in brokering and facilitation. The Mayoral Forum does not have existing funding to support that, and neither does the regional forums secretariat have the capacity or capability to drive this work.
18. If the MOU proceeds, strengthening the existing relationship with Nagano will involve Mayors and their councils in hosting delegations from time to time. If Mayors or other city/district representatives are visiting Japan for any other reason (e.g. on account of existing sister-city relationships), extending the visit to include Nagano Prefecture would be a cost-effective way of building and maintaining the relationship at governance-to-governance level.

Risk assessment and legal compliance

19. If the Mayoral Forum wishes to proceed with an MOU, the secretariat will work with the Civic and International Relations team at the Christchurch City Council to develop the final text of an MOU in consultation with General Counsel, negotiate this with the Nagano Prefectural Government through Tony Oikawa and report back to the Mayoral Forum on 25 May 2018.

Communication

20. If the Mayoral Forum agrees to proceed and an MOU is signed in October 2018, the secretariat will work with the Civic and International Relations team at the Christchurch City Council, ChristchurchNZ and the Canterbury Employers' Chamber of Commerce to publicise the MOU and the opportunities it represents to the education and training, agriculture, food and beverage, tourism and technology sectors.

Region-to-region MoU with Nagano Prefecture, Japan

Purpose

This paper seeks agreement in principle to develop a region-to-region relationship with Nagano Prefecture, Japan, for report back to the Mayoral Forum on 1 December 2017.

Recommendations

That the Canterbury Mayoral Forum:

- 1 **agree** in principle to develop a region-to-region relationship with Nagano Prefecture, Japan
- 2 **direct** the secretariat to work with Christchurch Educated and Christchurch City Council staff to draft a Memorandum of Understanding (MOU) with Nagano Prefecture and report back to the Mayoral Forum on 1 December 2017.

Background

- 1 Nagano Prefecture (formerly known as Shinshu) is in central Japan, between the Tokyo and Nagoya metropolitan areas. It is the fourth largest region in Japan, with a population (2015) of 2.1 million. It is ranked the happiest region in Japan, and is one of the highest ranked regions for education.
- 2 An MoU between the two regions would formalise and extend the existing relationship, which currently focuses on tertiary alliances, school relationships (including early childhood education and parenting programmes), study tours and teacher exchange.
- 3 There is an opportunity for the relationship to extend to a range of other opportunities, for example, 2019 rugby world cup tours, farm management education and tramping guides/sports instructors exchange programmes.
- 4 Nagano Prefecture and the Canterbury region both have 10 districts, and there are some marked similarities in geography and economic activity.
- 5 Mayors indicated support in principle (via email) for the Chair of the Mayoral Forum to explore the proposal.
- 6 On 14 August 2017, I met with Takeuchi Nobuhiko from the Nagano Prefectural Government, Asst Prof Tetsuhito Sakata from Teikyo University and Tony Oikawa, Japan Market Representative for Christchurch Educated.

Alignment with CREDS

- 7 The strong focus on international education aligns well to the Canterbury Regional Economic Development Strategy (CREDS) accelerator project to extend the Job Ready mentoring programme for international students to South Canterbury. This encourages

and support young, skilled migrants who have been educated in New Zealand to settle permanently in our region, augment our labour force and contribute to our communities.

- 8 The expansion of the Sister City concept to a 'cousin-region' arrangement, means that a wider array of offerings is available to both parties. The relationship could potentially extend beyond education, into employment / training exchanges and opportunities in tourism and farming.
- 9 The opposing seasons in both countries increases the potential for work and leisure exchanges in skiing, sports training and tourism. This aligns well with the CREDS Visitor strategy goal of attracting visitors outside the peak summer season.

Next steps

- 10 A draft of what a region-to-region relationship might look like, and an initial draft of a potential MOU are attached as Appendix A. This material has been provided by Tony Oikawa as *concept documents to support discussion between the parties*.
- 11 With Mayoral Forum agreement, the secretariat will work with Christchurch Educated and the international team at Christchurch City Council to develop a high-level MOU for Mayors to consider when they meet on 1 December 2017.
- 12 The MOU will be high level and mandate the subsequent development of a project plan and programme of practical actions with the Forum and its member councils.
- 13 If the Mayoral Forum agrees, the Chair could sign an MOU during a planned visit to Japan in March or April 2018.

Canterbury Water Management Strategy update

Purpose

- 1 This paper provides the Canterbury Mayoral Forum with an update on region-wide progress towards implementing the Canterbury Water Management Strategy (CWMS).

Recommendations

That the Canterbury Mayoral Forum:

- 1 **receives the progress report of implementing the CWMS in each district and across the region and discuss current challenges and opportunities**
- 2 **discuss Environment Canterbury's new format for the Canterbury Water Management Strategy update and recommend any improvements**
- 3 **discuss the best way to incorporate Territorial Authority updates into the paper.**

Key points

- 2 Water management remains a hot topic for Canterbury. 2018 began with CWMS committees welcoming new members and working on full agendas and key topics, Councils releasing important water decisions for public consultation through the LTP process, and often-emotive water topics in the media on a regular basis across the region.
- 3 A variety of water-related events, conferences and symposiums are scheduled for 2018.

Regional and Zone Committee updates

- 4 The Canterbury Water Management Zone and Regional Committees started the 2018 year with 14 new community members among them, and 11 members reappointed. Specific topics for focus in the first part of 2018 include:
 - the **Kaikōura and Hurunui Zone Committees** are working on three projects funded by Ministry of Primary Industry Earthquake Recovery grants (\$800,000). The projects help farmers re-evaluate their farming practices through research into earthquake effects on and beneath their land. In Kaikōura the effects of the State Highway and Kiwi Rail repairs on waterways and the coast have been closely monitored and there were no non-compliance issues.
 - as part of its sub-regional plan process, **Waimakariri Zone Committee** is considering the results of a scientific investigation that found low levels of 'nitrate-nitrogen' in aquifers and wells in Kaiapoi, Belfast and northern Christchurch.
 - the **Christchurch West Melton and Banks Peninsula Zone Committees** are involved with work to develop the Whakaraupo/Lyttelton Harbour Catchment

Management Plan (led by the Partners Governance Group and due for launch in March), and work to ensure that water quality standards are met through the new National Environmental Standard for forestry, especially for areas affected by the Port Hills fires in February 2017.

- the **Orari-Temuka-Ophi-Pareora (OTOP)** zone committee is seeking feedback on its Draft Zone Implementation Programme Addendum that recommends environmental limits and practical actions to protect and improve freshwater quality in the zone. Roadshows were held between 30 January and 21 February.
- Environment Canterbury is working on a system for improved collection and reporting on the practical projects being worked on in each zone. This CWMS update will increasingly include better data and updates enabled by the new system.

Ministry for the Environment update

- 5 Ngāi Tahu, Environment Canterbury, the Selwyn District Council and the Selwyn-Waihora Zone Committee hosted Hon. David Parker (Minister for the Environment, Trade and Export, and Economic Development) and officials on a day-long field trip to Te Waihora on 16 January 2018. The Minister heard Ngāi Tahu's perspective on the significance of Te Waihora, and discussed with the different parties the vision, practical work, efforts to restore the lake's mauri, and implications of Resource Management Act (RMA) rules on farming operations in the catchment. It was a positive trip and the Minister reported that he found it worthwhile and gave him a lot to think about.
- 6 The Minister and Ministry officials requested pieces of work during their visit and we pulled together responses to reach him late February. We hope this will inform his thinking around any changes to the RMA and the proposed National Planning Standards. We understand he is likely to provide direction to the Ministry on these matters in April 2018.

Environment Canterbury updates

Draft Long-Term Plan 2018–2028

- 7 Environment Canterbury's **draft Long Term Plan 2018–2028** is due for public consultation from 26 February to 26 March, with hearings scheduled for 30 April, 1 and 2 May leading to adoption by council on 21 June 2018. The Long-Term Plan (LTP) reflects the council's strategic priorities of freshwater management and indigenous biodiversity.
- 8 For the CWMS Portfolio, there is increased focus on implementation of the Land and Water Regional Plan in the form of support for individuals to meet compliance with new farming rules. Resources have been shifted to provide three cultural land advisors and two land management advisors and increased support for the Farm Environment Plan Audit Programme.
- 9 The LTP proposes to change the current region-wide targeted rate for the CWMS to a region-wide general rate for Freshwater Management. We have assigned resources to improve the monitoring of river flows, specifically those connected to irrigation takes, and provided additional support to manage the increased data from water users. This increased monitoring will help provide better information to manage the water resource and deliver on CWMS targets.

Farm Environment Plans

- 10 A key part of ensuring compliance with the Land and Water Regional Plan is Environment Canterbury's current focus on Farm Environment Plans (FEP). Under the Land and Water Regional Plan, 3800 of the 8800 agricultural farms in Canterbury require a land use consent to farm, and are required to have their FEP audited as part of their consent. The FEP is independently audited to check that risks are managed and Good Management Practices are applied to minimise impacts on water quality. Work is underway to help farmers develop and implement their FEPs, including Environment Canterbury's approval of Fonterra's farm environment plan template in January 2018 and Beef and Lamb New Zealand's free workshop in January to help farmers complete their Farm Environment Plan.

Braided rivers

- 11 Environment Canterbury has initiated a project (the BRIDGE project) to work with Territorial Authorities, CWMS committees and communities to provide certainty on the extent of braided river beds (and subsequently the areas of respective responsibilities of Environment Canterbury and territorial authorities). The project involves identifying the range of values within braided river environments. It is expected this process will develop the content and pre-notification process for a likely plan change (Canterbury Land and Water Regional Plan) notification in June 2019.

Canterbury Drinking Water Reference Group

- 12 The Government's report on the Havelock North Drinking Water Inquiry: Stage 2 was made publicly available on 6 December 2017. The report recommends urgent and early actions to prevent recurrences of an outbreak of waterborne disease in water supplies throughout New Zealand. The Government is currently considering the recommendations. In the meantime, the Ministry of Health has made it very clear that councils need to act now rather than wait until they are directed to make safety improvements.
- 13 The Canterbury Drinking Water Reference Group (made up of representatives from Environment Canterbury, all Canterbury councils and the Canterbury District Health Board Medical Officer of Health) has reviewed the recommendations and is continuing to share local knowledge and expertise around water supply issues in the Canterbury region. This has assisted local authorities and the Canterbury District Health Board to review and implement the recommendations that provide immediate improvement. It is intended that this collaborative way of working on drinking water will become business as usual.

Territorial Authority updates

- 14 Environment Canterbury's CWMS team would be grateful for advice on completing this section. Options include verbal updates from Territorial Authorities at the meeting or a request for information from each Territorial Authority prior to the meeting.

Community feedback

- 15 A **Community survey on waterways** has been undertaken by the Christchurch City Council. Over 400 people took part, and nearly 60% said Christchurch waterways were

in poor or very poor health. Only 55% of respondents said they knew where storm water went once it entered the drain network. The majority said they were prepared to make lifestyle changes and/or take part in waterways clean-up activities. Next steps involve working with smaller groups to identify activities and behaviours that will best achieve improvements to the health of waterways. In the news

Cyanobacteria warnings

- 16 Cyanobacteria warnings have been in the news over the summer, but Environment Canterbury has not issued more warnings than in previous years. Saltwater Creek is the only 'new' site that is not one of the regular cyanobacteria warning sites, caused by very low rainfall during November that resulted in very low water levels and very warm water temperatures.
- 17 Environment Canterbury continues to fund research into the drivers of cyanobacteria blooms regionally, and is involved in a national working party looking into the ramifications and rationale of including benthic cyanobacteria as one of the National Policy Statement attributes.
- 18 Environment Canterbury continues to work with Community and Public Health and Territorial Authorities to inform the community about the risk of cyanobacteria through its contact recreation program.
- 19 A late media release for the warning in South Canterbury was discussed in the media in January, caused by a Community and Public Health staff member being on leave. The warning system is under review to ensure no further issues.

Chlorination of Christchurch's drinking water

- 20 Chlorination of Christchurch's drinking water was in the media in January after Canterbury's Medical Officer of Health Alistair Humphrey recommended to the Christchurch City Council that drinking water should be temporarily treated while well heads are fixed. City Councillors voted to temporarily chlorinate the water, expected to happen by the end of March 2018.

Environment Canterbury representation review

Purpose

1. This paper describes the Local Electoral Act 2001 process and timeline for Environment Canterbury's representation review to take effect at the local authority elections in 2019.

Recommendations

That the Canterbury Mayoral Forum:

1. **note that Environment Canterbury will undertake a representation review in 2018, with an initial proposal required by 31 August 2018**
2. **note that Environment Canterbury will work with relevant staff from Canterbury councils to develop representation options for the review.**

Background

2. At least once every six years, a council is required to undertake a representation review. The Environment Canterbury (Transitional Governance Arrangements) Act 2016 requires Environment Canterbury to review its representation arrangements before the next local authority elections in 2019.
3. An initial proposal is required by 31 August 2018. Appendix 1 contains a proposed timeframe outlining the steps required.
4. Representation reviews determine detailed arrangements for the number of electoral constituencies, their boundaries, names and number of members. The Local Electoral Act 2001 (LEA) sets the parameters within which the representation review process must be undertaken.
5. Under the LEA, local authorities must provide for 'effective representation of communities of interest' and 'fair representation of electors'. The following three key principles must be considered when undertaking a review.
 - Identify **communities of interest**. Communities of interest are not defined in legislation. The Local Government Commission guidelines describe a community of interest as *'an area where one feels a sense of belonging; where one looks for social, service and economic support; and an ability for the elected body to represent the interests and reconcile the conflicts of all its members.'*

- Determine **effective representation** of communities of interest. Effective representation relates to representation of identified communities of interest. This needs to take account of the nature and locality of those communities of interest and the size, nature and diversity of the region as a whole. The need for effective representation of communities of interest will determine the basis of election.
 - Consider **fairness of representation** for electors of constituencies. Membership of constituencies is required to provide approximate population equality per member; i.e. all votes are of approximately equal value (referred to as the +/-10% rule) unless there are good (prescribed) reasons to depart from this requirement. A decision by a local authority not to comply with the +/-10% rule must be referred to the Local Government Commission for determination.
6. Two decisions have already been agreed by Environment Canterbury counsellors regarding the review:
- voting will continue to use the Single Transferable Vote (STV) system
 - there will not be dedicated Māori seats (at the request of Ngāi Tahu).
7. Workshops will be held in early April and May with relevant staff from across Canterbury councils to develop representation options and provide feedback on the initial draft proposal.
8. Of the 10 territorial authorities within the Environment Canterbury region, six are undertaking representation reviews in 2018. These are: Kaikōura, Hurunui, Ashburton, Timaru, Waimate and Waitaki.

Chief Executives Forum report

Purpose

1. This paper reports on the work of the Chief Executives, Corporate, Operations and Policy Forums and presents a revised presentation of the Three-year work programme for approval.

Recommendations

3. **agree to include the establishment of a Public Records Act Executive Sponsors Working Group as an item in the Three-year work programme.**

Chief Executives Forum

2. The Chief Executives Forum met on 12 February, and agreed to:
 - discontinue the strategic assessment of the case for change in management of 3 Waters, and commission a re-focused piece of work to be undertaken by the Operations Forum on management of 3 Waters by Canterbury local authorities
 - establish a Canterbury Public Records Act Executive Sponsors working group, reporting to the Corporate Forum
 - accept the proposed cost share formula for contaminated land shared services.
3. Other agenda items included updates on:
 - CREDS funding and implementation (**agenda items 6–7**)
 - investigation of valuation and rating shared services
 - CWMS implementation and national water initiatives (**agenda item 10**)
 - Environment Canterbury's upcoming representation review (**agenda item 11**)

Corporate Forum

4. The Corporate Forum met on 29 January 2018, and agreed to:
 - support the establishment of a Canterbury Public Records Act Executive Sponsors working group.
5. Other agenda items included:
 - discussion of challenges in investigating opportunities for shared valuation and rating services
 - discussion on the future of shared services across Canterbury councils, given investment and software cycles, and what potential initiatives could provide the biggest difference to the public. The Corporate Forum will consider potential projects, including a case study of existing shared services between Hurunui, Kaikōura and Mackenzie, and consideration of training and succession planning.
 - updates from the Canterbury Finance Managers and Chief Information Officers working groups.

Operations Forum

6. The Operations Forum met on 29 January 2018, and agreed to:
 - propose discontinuing the strategic assessment of the case for change in management of 3 Waters, and commission a new piece of work on management of 3 Waters by Canterbury local authorities
 - invite the chair of the Health and Safety working group into the Operations Forum, following communication from the Environmental Protection Authority on compliance and enforcement of the Hazardous Substances and New Organisms Act across councils.
7. Other agenda items included:
 - discussion on taking a stronger customer focus and consistent application of approaches in the implementation of the Mayoral Forum's three-year work programme
 - a case study of Timaru District Council's response to asbestos found in the Temuka water supply in December 2017
 - updates from the Canterbury Engineering Managers, Natural Hazards Working Group, Regional Stormwater Forum, Drinking Water Reference Group, and Regulatory Managers Working Group.


Policy Forum

8. The Policy Forum met on 2 February 2018. Agenda items included:
 - recent Government developments, including implementation of the first 100-Day Plan and Minister Parker's visit to Canterbury on 16 January 2018. Members were interested to clarify how initiatives committed to by the previous government will progress, and to identify opportunities for Canterbury regional forums to engage and influence longer term government policy and initiatives.
 - a round table on 2018–2028 Long-Term Plans, including key changes, new projects and impact on ratepayers
 - continuing previous discussions on addressing the biodiversity challenge, focusing on national-level developments and encouraging investment opportunities to maximise the 'public good' benefits of biodiversity
 - update on CREDS funding and implementation
 - updates from the Canterbury Planning Managers and the new (RMA) Compliance Monitoring and Enforcement working group.

Three-year work programme

9. Chief Executives reviewed the three-year work programme and asked the secretariat to:
 - give greater visibility to CREDS work programmes (and not only the 'accelerator projects' funded from the Regional Growth Programme)
 - cluster other work programme items, to make the report more focused and digestible.
10. A revised format has been circulated with this report for Mayoral Forum approval. Updates since the December meeting are indicated in red type.
11. The Chief Executives Forum recommends including the establishment of a Public Records Act Executive Sponsors Group as a new item on the Three-year work programme – under Collaboration and shared services.
