CANTERBURY POLICY FORUM

The Canterbury Policy Forum met on 7 April 2017.

- The Forum discussed climate change issues in relation to councils and agreed to set up a regional working group to progress thinking and planning across the region about climate change.
- In response to the recommendations of the Environmental Defence Society's recent report on compliance, monitoring and enforcement of environmental law, the Forum agreed to set up a regional working group to share knowledge and expertise on compliance and enforcement.
- Legislation that is likely to require a regional response in 2017 was identified and discussed. The secretariat is organising a one-day workshop on submission writing for council staff.
- The Forum discussed the range of activities taking place in fresh water management.
- Forum members supported the establishment of two new regional forums
 Operations and Finance which will ensure we make the most of expertise and knowledge across the region.
- An update from the Canterbury Mayoral Forum included progress on the revised Canterbury Regional Economic Development Strategy due to be launched in June.
- Updates were provided on the Long-Term Plan working group, the new regional Health and Safety Advisors Group, the Rating and Valuation Services project and the Planning Managers group.
